- Mitchell asks what Stary sees as the implications for this; Stary shares Mitchell's sentiment and says we need to restore public confidence in the justice system; he agrees we need a Royal Commission and is afraid what's occurred will significantly erode public confidence in the system; he says we need a 'cathartic analysis' of everything that's happened
- Mitchell asks Stary if people who are currently in jail will come out of jail; Stary says we don't know if 'Lawyer X', when representing gangland figures, was also acting as an informer and how that would impact on their conviction and require re-trial; he says the OPP needs to undertake a review of each case; he says we need to understand the role of VicPol in this
- Mitchell asks what the police have potentially done in terms of corruption; Stary says we know there were 46 successful prosecutions of police during the period including the head of the Drug Squad; he confirms there has been widespread corruption and there were calls for a Royal Commission 10 years ago that were resisted by both sides of politics; he says we received 'watered down' ICAC reports from NSW and Qld
