I am currently performing the role of a [REDACTED] attached to the Source Development Unit. I have been a [REDACTED] for over [REDACTED] years, since [REDACTED]. I feel a secondment opportunity to the Drug Task Force will develop my skills in directions that I intend to go in the near future.

During my [REDACTED] years as a [REDACTED] I have [REDACTED] managed numerous complex Divisional and Crime Squad investigations. These investigations have employed every form of evidence gathering technique, including electronic and physical surveillance, available to Police. During these investigations I have made working relationships with outside organisations including Australian Federal Police, Australian Customs Service Australian Crime Commission, Department of Foreign Affairs and Trade and Australian Tax Office. This is in line with the Service Delivery Model in that it builds a capacity internally and | externally creating an ability to deliver outcomes with greater efficiency and effectiveness. These investigations have also used the support of Regional services and their specialist area knowledge. The results of these investigations have lead to successful prosecutions after I actioned the preparation of complex briefs of evidence. I have successfully [REDACTED] investigators and know what motivates them in order to achieve specific local and organisational strategies and plans. My integrity and trustworthiness are held in high regard and I have passed the highest level of probity checks to be selected to my current position.

During my secondment to the [REDACTED] various covert policing techniques were used. Such were the targets and techniques being used, that high level assistance was needed to maintain the appropriate level of inter-agency and organisational co-operation. The Victorian community's expectations for a secure and successful outcome were high. Reporting of the task force activities went directly to the Chief Commissioner.

[REDACTED] focussed on a number of operations that have since been

successfully concluded. The offences investigated by me whilst attached to the Task Force were organised crime based and included drug manufacturing, trafficking and importing.

Whilst I was at the [REDACTED] an opportunity was offered to me, to be a part of the development of the Dedicated Source Unit. This unit was formed in keeping with international trends in source management and to risk manage areas of our organisation. Being a part of the pilot project and now gazetted to the Source Development Unit has been an exciting part of my career. It exposed me to change and initiatives being actioned and implemented. The experience I gained has fuelled my desire to now enhance my career to a new level.
