Dear Fin

Attached is a letter received this morning rejecting [REDACTED] we provided to Witness F. It advises that the document is 'wholly unacceptable and has no prospect of resulting in any agreement or resolution'.

The letter:

- records that Witness F is no longer interested in participating in the Program;
- repeats that all contact with the Witness must now be made through Piper Alderman, and contact by Petra Taskforce members must be discontinued;
- claims compensation as promised and represented to Witness F, including for damage to the witness' health;

- invites authorised representatives of Victoria Police to negotiate with Mark Waters and Witness F's senior counsel, John Dixon SC, as to the matters claimed; and
