Afternoon all,

Please be advised that I spoke to Witness F on Tuesday (24th August) about arranging for [REDACTED] Operation [REDACTED]. All communications with [REDACTED] are done via Witness F. A meeting has been arranged with [REDACTED] [REDACTED] for the 10th of Sept.

Prior to contacting Witness F I obtained approval to contact F from Inspector John O'CONNOR. John now has the responsibility of managing Witness F.

John O'CONNOR was today ( 26th August) advised by Supt. Lardner that no tasking of Witness F is to occur as part of the settlement of the writ issued against Vic Pol. John O'CONNOR was not aware of these instructions and was only advised today (thus the approval being granted to contact witness F). Aside from this I don't believe my contact is a tasking in the sense that Witness F is acting as a conduit to [REDACTED].

Forwarded for information. Supt. Lardner will be briefing A/C Moloney regarding this contact.
