STATEMENT

Name: Mr Bickley

STATES:

My full name is Mr Bickley and I live at an address known to the police.

I make this statement in the belief that any information contained herein will not be used against me in any criminal proceedings. I am making it of my own free will and under no duress.

On 16 February 2007, I then went to the Crown Casino Complex, Food Court area, with another male named Charlie.

When we arrived at the food court I called Rob using the phone number in my phone. I told Rob I was downstairs and he stated that he would be down in a minute. Rob arrived a short time later, I introduced him to Charlie and Rob said lets go for a walk. Rob, Charlie and I then went for a walk along the Yarra towards the Poly Woodside. We then stopped and spoke about the deal. Rob stated that we could jump on this 3 or 4 times and that know one would know the difference. Rob then took a plastic bag out of his rear pocket and held it in his hand against a pylon, I then took it from Rob and handed it to Charlie. Charlie then got the cash out of his backpack. Charlie then handed the money to Rob in a white paper bag, which Charlie had got from the café at the food court. Rob then put the money into his back pocket. Charlie and Rob then spoke about suppliers.

We all then began to walk back to the Casino along the Yarra. I asked Rob about chemicals to make ecstasy and Rob stated that he would put me onto someone. Rob told us that he had 5 kg's of coke, Charlie asked him if he had it with him and Rob said no, he doesn't keep it with him.

Rob told us that he doesn't make anything out of this and that he would introduce Charlie and I to his supplier of the coke. Rob also stated that he was doing something with a mate which was making him a lot of money. The supplier is also Rob's business partner.
