Telephone Intercepts & Listening DevicesTI's

All 9 Telephone Intercept Warrants continue to be managed at ESD. 9 targets and various telephones are subject to interception plus a [REDACTED] near target Shea's residence on the Gold Coast. All warrants have been successfully extended to 14-November-2007.

Financial investigation

Jim Corcoran from MFID has commenced financial profiles on the suspects. Awaiting return of all details from financial institutions prior to execution of warrants.

Legal

Meeting with Geoff Horgan 3/7/07. He advised that all targets with exception of Mather should be charged on the basis of **Mr Gregory** statement and the corroborated aspects of same.

HORGAN and TINNEY advised 5/9/07 re efficacy of coercive hearings with suspects prior to any 464 interview. Advised no problem with same.
