I am [REDACTED] years.

I make this statement of my own free will.

On Monday 24 April 2006 I was [REDACTED] Detective Sergeant Dale Flynn. I was aware that police were monitoring my movements and recording my conversation at the time.

At 8.26 pm I attended at 'The Grove Café' 153 Sydney Road Brunswick.

I met with Horty Mokbel in the Brunswick area. We discussed the following,

- Horty wanted to know if any amphetamine powder was around and he would take the lot if I had any.
- I emphasized I needed to see his brother Milad to acquire some glassware to complete the manufacture. I said that I must speak to his brother first and then we would speak. After talking with Milad, I would discuss with Horty that the product would be ready for him on Wednesday, if not earlier and that I hadn't forgotten about him.
- I agreed to supply 5 to 10 pounds or what ever was left for \$40,000.00 per pound. He said OK, no problem and we agreed I would leave it in the rubbish bin at his house on Wednesday or earlier. Horty agreed he would give me no less than \$100,000.00 a short time later.

A short time later I met with Milad Mokbel. We discussed,

- He couldn't retrieve methylamine tonight but he had the condenser not far away. I had previously told him I needed the duo-condenser and methylamine to finish the product for him which would have been 7 kilograms of amphetamine.
- Walking back to the coffee shop we stopped at a house where he instructed Habib Mokbel to retrieve a cardboard box containing the duo-condenser and put it in the front seat of the 4WD I was driving.
- We discussed that he would dispose my equipment after I was sentenced and in gaol.
- He offered to finish gassing the product that was left at the lab after I was gone. It was agreed that he could take care of it. We then discussed of him purchasing product where he agreed he would take 5 elbows (5 pounds) at \$37,500.00 each. He would organize the money and have the drop off made at his house. He

instructed me to wrap the box where it would look like an easter gift. We agreed that the exchange would happen at 6.00 o'clock the following evening.

This meeting concluded at about 9.00 pm. A short time after this I left this location and
