

Doug says

- Investigating Dale re lies to P^{II}
- Decided not to call F as witness
- Wouldn't accept her terms of safety
- VicPol told F that; cannot use you as a witness without her accepting VicPol security arrangements

Fin [McRae] said that

- F is mentally unwell
- F wants to be hero witness
- Risk to her is serious if she were witness against Dale (or others too)

JC [John Champion] said

Doug [Fryer] said
