WITNESS F: It's not - - -

DETECTIVE INSPECTOR O'CONNOR: This is - - -

WITNESS F: At least it's not - - -

DETECTIVE INSPECTOR O'CONNOR: - - - fairly new?

WITNESS F: - - - hard to park.

DETECTIVE INSPECTOR O'CONNOR: You can get - - -

WITNESS F: It's always easy to park around here.

DETECTIVE INSPECTOR O'CONNOR: Yeah.

WITNESS F: Yeah.

DETECTIVE INSPECTOR O'CONNOR: Not like the city.

WITNESS F: No, it's a nightmare.

DETECTIVE INSPECTOR O'CONNOR: I'll tell you what, the city - I parked there a little while ago, only parked for half an hour and it's, like, \$35.

WITNESS F: Yeah, that's right.

DETECTIVE INSPECTOR O'CONNOR: Absolute - anyway - - -

WITNESS F: Fortunately I've got permanent nerve damage in my leg - - -

DETECTIVE INSPECTOR O'CONNOR: Yeah.

WITNESS F: - - - and I've got a disabled park.

DETECTIVE INSPECTOR O'CONNOR: Oh, you've got a - yeah.

WITNESS F: But it doesn't - it - it only will last, yeah, for this year. So after that I won't have anything any more.

DETECTIVE INSPECTOR O'CONNOR: Yeah.

WITNESS F: But - well, I mean, I'll probably qualify, yeah,
'cos it's more permanent damage. But it does - it - it
is a handy help.

DETECTIVE INSPECTOR O'CONNOR: Yeah, yeah. That's actually - - -

WITNESS F: But that'd be - - -

DETECTIVE INSPECTOR O'CONNOR: My pet hate is people parking in the disabled - - -

WITNESS F: Well, yeah.

DETECTIVE INSPECTOR O'CONNOR: - - - parking who - - -

WITNESS F: I agree.

DETECTIVE INSPECTOR O'CONNOR: - - - who haven't got a - - -

WITNESS F: Yeah. Well - - -

DETECTIVE INSPECTOR O'CONNOR: - - - got a sticker.

WITNESS F: You know, it's the - the written law you've gotta go through to get one - - -

DETECTIVE INSPECTOR O'CONNOR: Mm.

WITNESS F: - - - is actually quite difficult. You've gotta

have - I've gotta - and not a GP's letter, that's not

good enough. You've gotta have a specialist report, and in the report they've gotta say - like, include an x-ray or include a CAT scan or something to prove what the problem is.

WITNESS F: I'd often - I don't often take them because I'm not disabled enough. Unless it's - unless it's a long walk or unless I'm using my walking stick or something.

DETECTIVE INSPECTOR O'CONNOR: Mm.

WITNESS F: 'Cos otherwise it's - there are people - - -

DETECTIVE INSPECTOR O'CONNOR: Are you using - - -

WITNESS F: Plenty of people - - -

DETECTIVE INSPECTOR O'CONNOR: - - - your stick at the moment or what?

WITNESS F: (NO AUDIBLE REPLY)

DETECTIVE INSPECTOR O'CONNOR: Good.

WITNESS F: Well - well, not when I don't have to walk far.

DETECTIVE INSPECTOR O'CONNOR: No, that's good.

DETECTIVE INSPECTOR O'CONNOR: Mm.

WITNESS F: But to not be short-tempered, to not be short with people, to not be shovelling drugs in and then dealing with the side effects of them - -

DETECTIVE INSPECTOR O'CONNOR: Mm.

WITNESS F: - - - to not be freezing cold all the time, which is one side effect, would just be amazing. So anyway - - -

DETECTIVE INSPECTOR O'CONNOR: Well, I hope it - I hope it works out.

WITNESS F: Well, it's only - look, it's only a consultation and - - -

DETECTIVE INSPECTOR O'CONNOR: Well - - -

WITNESS F: Yeah.

DETECTIVE INSPECTOR O'CONNOR: But the - it's - another door opens.

WITNESS F: Yeah.

DETECTIVE INSPECTOR O'CONNOR: Now, I've been just - I've been given a - an envelope with a letter.

WITNESS F: Have you read it?

DETECTIVE INSPECTOR O'CONNOR: No, it's a - - -

WITNESS F: Oh.

DETECTIVE INSPECTOR O'CONNOR: It's - it's a sealed envelope.

I've just been instructed to hand it to you.

WITNESS F: How come - - -

DETECTIVE INSPECTOR O'CONNOR: So - - -

WITNESS F: --- you have to? Not like last time when they turned ..... on my door.

DETECTIVE INSPECTOR O'CONNOR: Dunno, dunno. I just - - -

WITNESS F: That's - - -

DETECTIVE INSPECTOR O'CONNOR: - - - got - - -

WITNESS F: -- really weird.

DETECTIVE INSPECTOR O'CONNOR: Yeah. I don't - there's no - I

don't think there's any conspiracy theory amongst it,

it's just that I got rung up by Legal Services or

whatever it's called within Victoria Police and

asked - - -

WITNESS F: Yeah.

DETECTIVE INSPECTOR O'CONNOR: - - - to deliver a letter to you. So - - -

WITNESS F: But last time they - when someone - when someone from Keiran's office turned up at my front door ...... quite unexpectedly.

DETECTIVE INSPECTOR O'CONNOR: Mm.

WITNESS F: And he was pretty pissed off 'cause I hadn't rung him back, but he was ringing a - an old mobile number

that I haven't used for a couple of years.

DETECTIVE INSPECTOR O'CONNOR: Yeah. Well, it's a bit hard to ring back then if you haven't got it.

WITNESS F: Yeah. Well, he said to me, don't you return your phone calls? And I said - - -

DETECTIVE INSPECTOR O'CONNOR: Yeah, no, yeah.

WITNESS F: - - - I haven't got a message.

DETECTIVE INSPECTOR O'CONNOR: Don't worry - - -

WITNESS F: - - -

DETECTIVE INSPECTOR O'CONNOR: - - - about that. So I've - it's - it's in a - - -

WITNESS F: Do I have to - - -

DETECTIVE INSPECTOR O'CONNOR: It - - -

WITNESS F: - - - sign something?

DETECTIVE INSPECTOR O'CONNOR: No, no.

WITNESS F: Yeah.

DETECTIVE INSPECTOR O'CONNOR: It's just in a - - -

WITNESS F: ......

DETECTIVE INSPECTOR O'CONNOR: So - - -

WITNESS F: - - - the envelope ......

DETECTIVE INSPECTOR O'CONNOR: Just put it - so - - -

WITNESS F: Doesn't feel very thick, only - - -

DETECTIVE INSPECTOR O'CONNOR: I dunno.

WITNESS F: - - - feels like it's one page. Mine was ten and a half, John. I would've expected a little - - -

DETECTIVE INSPECTOR O'CONNOR: No.

WITNESS F: --- bit more.

DETECTIVE INSPECTOR O'CONNOR: The - well - - -

WITNESS F: Actually I do - - -

DETECTIVE INSPECTOR O'CONNOR: I don't read - I don't read these things.

WITNESS F: I know - - -

DETECTIVE INSPECTOR O'CONNOR: So - - -

WITNESS F: - - - why. And I know why he's responded this way.

DETECTIVE INSPECTOR O'CONNOR: So that's all I have to do.

WITNESS F: O.K.

DETECTIVE INSPECTOR O'CONNOR: So - - -

WITNESS F: I wasn't - I wasn't gunna ring you to ask you about Rob Karam.

DETECTIVE INSPECTOR O'CONNOR: Mm.

WITNESS F: I was just gunna ring you to let you know that - - -

DETECTIVE INSPECTOR O'CONNOR: Yeah.

WITNESS F: -- as a consequence of him stealing my credit card --

DETECTIVE INSPECTOR O'CONNOR: Yep.

WITNESS F: - - - and using it, like, some charges appeared on my credit card. I rang up the Western Hotel in - oh, the Sofitel in Sydney and said, hello, I wasn't there. I've never - - -

DETECTIVE INSPECTOR O'CONNOR: Yeah.

WITNESS F: - - - stayed there. And how did this happen?

DETECTIVE INSPECTOR O'CONNOR: And you haven't been to Nigeria?

WITNESS F: Nope.

DETECTIVE INSPECTOR O'CONNOR: No, yeah.

WITNESS F: Or any of the other ones - - -

DETECTIVE INSPECTOR O'CONNOR: Yeah.

WITNESS F: - - - on that card. And they - some of them they couldn't tell me who it was but - but at that hotel he's used his own name, checked in.

DETECTIVE INSPECTOR O'CONNOR: With your credit card?

WITNESS F: Yes.

DETECTIVE INSPECTOR O'CONNOR: O.K. Well, I'll - - -

WITNESS F: I was just gunna say - - -

DETECTIVE INSPECTOR O'CONNOR: How much - - -

WITNESS F: - - - it's a matter of - it's three - it's 2600.

DETECTIVE INSPECTOR O'CONNOR: Yep. So you want to report the matter?

WITNESS F: Yeah.

DETECTIVE INSPECTOR O'CONNOR: Yeah, all right. I'll arrange for a - someone - well, I'll get back to you with someone who - - -

WITNESS F: Oh, you don't want me - - -

DETECTIVE INSPECTOR O'CONNOR: - - - you feel is safe.

WITNESS F: -- to go to a police station?

DETECTIVE INSPECTOR O'CONNOR: I don't - I will just go - probably I'll go with a detective at this stage.

WITNESS F: O.K., all right.

DETECTIVE INSPECTOR O'CONNOR: Yeah.

WITNESS F: I rang - I've only been - I've only dealt with the WitF-020521012.001 21

- with Sofitel because they were - they were the only people who were able to tell me - - -  $\!\!\!$ 

DETECTIVE INSPECTOR O'CONNOR: Mm.

WITNESS F: -- that it was him.

DETECTIVE INSPECTOR O'CONNOR: Yeah.

WITNESS F: And when I said to them, well, how is it that my card has been used when this person has checked into the hotel? Because - - -

DETECTIVE INSPECTOR O'CONNOR: Because your - - -

WITNESS F: - - - you have to - - -

DETECTIVE INSPECTOR O'CONNOR: - - - card's - the card's in your name and - - -

WITNESS F: Exactly.

DETECTIVE INSPECTOR O'CONNOR: - - - he's - and - and - - -

WITNESS F: Exactly.

DETECTIVE INSPECTOR O'CONNOR: - - - he's different, yeah.

WITNESS F: And they immediately - well, they immediately panicked and said, it's all right, we'll - we'll check it out but we'll refund you the money - - -

DETECTIVE INSPECTOR O'CONNOR: Mm.

WITNESS F: - - - straightaway.

DETECTIVE INSPECTOR O'CONNOR: So have you got copies of the statements?

WITNESS F: Yeah.

DETECTIVE INSPECTOR O'CONNOR: Yep, all right.

WITNESS F: Yeah.

DETECTIVE INSPECTOR O'CONNOR: So you're able to do that?

You - - -

WITNESS F: Got it all.

DETECTIVE INSPECTOR O'CONNOR: You'll make a statement, all that type - - -

WITNESS F: Yeah.

DETECTIVE INSPECTOR O'CONNOR: - - - of stuff? All right.

I'll come - I'll come back to you with - - -

WITNESS F: And it - and - - -

DETECTIVE INSPECTOR O'CONNOR: - - - someone who you can report - - -

WITNESS F: For what - - -

DETECTIVE INSPECTOR O'CONNOR: - - - it to.

WITNESS F: - - - it's worth, I've rung him, I've text messaged him, emailed him, and rung him - - -

DETECTIVE INSPECTOR O'CONNOR: So what are you out of pocket?

WITNESS F: 2600.

DETECTIVE INSPECTOR O'CONNOR: Yep, all right.

WITNESS F: I'm just not gunna wear it, John.

DETECTIVE INSPECTOR O'CONNOR: No, it's - - -

WITNESS F: .....

DETECTIVE INSPECTOR O'CONNOR: - - - up to you. You're like anyone else so - - -

WITNESS F: Yeah. And anyway, the - the chick at the Sofitel
in Sydney said to me, are you sure you didn't stay here?
I said, well, I know the date, I was in hospital on the

WITNESS F: Yeah.

WITNESS F: That's the problem.

DETECTIVE INSPECTOR O'CONNOR: It may be a New South
Wales - - -

WITNESS F: And that's the problem.

DETECTIVE INSPECTOR O'CONNOR: - - - matter. And I'm no expert on New South Wales, I'm - - -

WITNESS F: No. I think - - -

DETECTIVE INSPECTOR O'CONNOR: - - - afraid to say.

WITNESS F: --- to find out.

DETECTIVE INSPECTOR O'CONNOR: But the one you know is, in fact - - -

WITNESS F: Definitely him.

DETECTIVE INSPECTOR O'CONNOR: - - - definitely him - - -

WITNESS F: O.K.

DETECTIVE INSPECTOR O'CONNOR: - - - I'll come back to ya.

WITNESS F: Look, I'm not - I'm still a bit hesitant about putting him in like that because, you know, he's either - he's gunna still be on bail as of next week.

DETECTIVE INSPECTOR O'CONNOR: Mm.

WITNESS F: But first what's he gunna do to me? Whatever he's gunna do, he's gunna do it.

DETECTIVE INSPECTOR O'CONNOR: Well, that's - that's a matter for you, Nicola. I'll - - -

WITNESS F: I know, but I - - -

DETECTIVE INSPECTOR O'CONNOR: I'll - I'll - - -

WITNESS F: - - - shouldn't be - he wants me as - - -

DETECTIVE INSPECTOR O'CONNOR: Yeah.

WITNESS F: I should be scared. I should - that's exactly the reason what these - why these people do what they do, because - - -

DETECTIVE INSPECTOR O'CONNOR: Mm.

WITNESS F: -- they figure you'll never do anything about it.

DETECTIVE INSPECTOR O'CONNOR: Yeah. Well, that's a decision for you to - - -

WITNESS F: Yeah.

DETECTIVE INSPECTOR O'CONNOR: - - - make, if you want to - if
you want to report it. But it's - so we're talking about
\$1700 for Sofitel - - -

WITNESS F: Flights and - - -

DETECTIVE INSPECTOR O'CONNOR: - - - in New South - - -

WITNESS F: - - - accommodation.

DETECTIVE INSPECTOR O'CONNOR: Accommodation in New South Wales and the - in Sydney. When - when was it?

WITNESS F: The 7th of December last year.

DETECTIVE INSPECTOR O'CONNOR: O.K., all right, no worries.

WITNESS F: And I was a at the so it definitely wasn't me.

DETECTIVE INSPECTOR O'CONNOR: No, no. It's all right.

WITNESS F: So with this - if I'm responding to this - depending on what's in it, am I responding the way I responded last time or am I responding - - -

DETECTIVE INSPECTOR O'CONNOR: I dunno.

WITNESS F: --- to you?

DETECTIVE INSPECTOR O'CONNOR: How did you respond? No.

WITNESS F: Well - - -

DETECTIVE INSPECTOR O'CONNOR: No, this is from Keiran Walshe.

Just write "To Keiran Walshe".

WITNESS F: Well, no, last time they told me to ring up his chief of staff and drop a response off.

DETECTIVE INSPECTOR O'CONNOR: I dunno, I dunno what's in the letter.

WITNESS F: O.K.

DETECTIVE INSPECTOR O'CONNOR: Read the letter, come back to me if you want.

WITNESS F: Well, my letter was - - -

DETECTIVE INSPECTOR O'CONNOR: But it - it - it - it - - -

WITNESS F: My letter - - -

DETECTIVE INSPECTOR O'CONNOR: But - - -

WITNESS F: - - - was merely offering to give evidence - further evidence - more evidence and - and not have any protection. So that's what the response will be.

DETECTIVE INSPECTOR O'CONNOR: I haven't read the letter so I don't know. So - oh, sorry. All right?

WITNESS F: Yeah. Well - - -

DETECTIVE INSPECTOR O'CONNOR: So I'll - I'll - - -

WITNESS F: Hopefully ......

DETECTIVE INSPECTOR O'CONNOR: I'll come back to you. And the letter will probably - I assume it'll say something about if you have further inquiries ring - I assume it'll be his staff officer.

WITNESS F: Yeah.

DETECTIVE INSPECTOR O'CONNOR: He's the deputy commissioner so I assume it will be.

WITNESS F: And if another one .......

DETECTIVE INSPECTOR O'CONNOR: He's retiring, yeah.

WITNESS F: Yeah.

DETECTIVE INSPECTOR O'CONNOR: So it's all right.

WITNESS F: ..... and then someone else will get a promotion.

DETECTIVE INSPECTOR O'CONNOR: Take care, hope it works well with - - -

WITNESS F: Yeah, well - - -

DETECTIVE INSPECTOR O'CONNOR: - - -

WITNESS F: ...... I mean, the - the research is pretty mixed. There's some people that say what I've got is incurable and - - -

DETECTIVE INSPECTOR O'CONNOR: Mm.

WITNESS F: -- that's just it, and there's some that suggest that surgery will make it better.

DETECTIVE INSPECTOR O'CONNOR: Mm.

WITNESS F: Or can - or can he say to me that operating might result in an improvement. Cause if it might result in an improvement then the - - -

DETECTIVE INSPECTOR O'CONNOR: Then you take the - - -

WITNESS F: Yeah.

DETECTIVE INSPECTOR O'CONNOR: - - - take the chance. All the best - - -

WITNESS F: Thank you.

DETECTIVE INSPECTOR O'CONNOR: - - - Nicola.

WITNESS F: We'll see - - -

DETECTIVE INSPECTOR O'CONNOR: Take care.

WITNESS F: --- what happens.

DETECTIVE INSPECTOR O'CONNOR: All right. I'll get back to you - - -

WITNESS F: Yeah, don't worry - - -

DETECTIVE INSPECTOR O'CONNOR: I'm gunna be - - -

WITNESS F: .....

DETECTIVE INSPECTOR O'CONNOR: I'll - I'm just gunna be on a few days off so I'll - it might not be till next week or the - - -

WITNESS F: Yeah, no.

DETECTIVE INSPECTOR O'CONNOR: - - - week after.

WITNESS F: No, no.

DETECTIVE INSPECTOR O'CONNOR: All right. There's no - - -

WITNESS F: .....

DETECTIVE INSPECTOR O'CONNOR: It's a deception so there's no rush. It's - - -

WITNESS F: That's right.

DETECTIVE INSPECTOR O'CONNOR: It's a paper trail.

WITNESS F: Exactly.

DETECTIVE INSPECTOR O'CONNOR: I don't have to tell you - - -

WITNESS F: And - and I think that Sofitel - they said they'll refund us. Whether it's this week or next week, it doesn't matter.

DETECTIVE INSPECTOR O'CONNOR: Yeah.

WITNESS F: I paid it to avoid the interest fee charges.

DETECTIVE INSPECTOR O'CONNOR: Yes.

WITNESS F: So there's no - - -

DETECTIVE INSPECTOR O'CONNOR: Very unforgiving, the banks.

Aren't they?

WITNESS F: Yeah. Gee, they don't wanna ......

DETECTIVE INSPECTOR O'CONNOR: All the best.

WITNESS F: Thank you.

DETECTIVE INSPECTOR O'CONNOR: See you, Nic, bye. Thank you.
